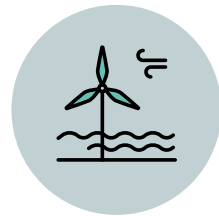

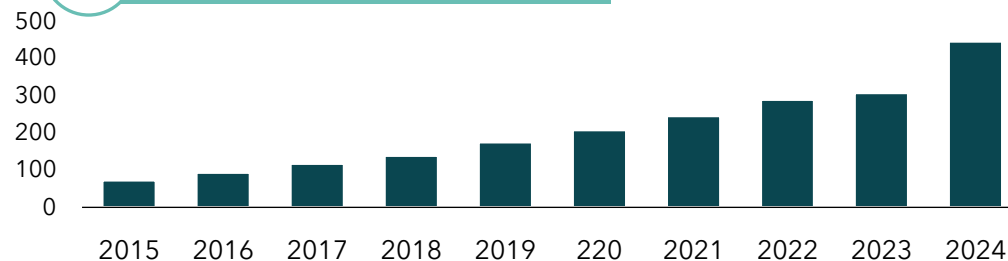

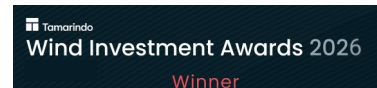
10-year growth in deal count
